About The Training Programe:

Rapid changes have been witnessed in all spheres of development during the last few decades, owing mainly to development of technology and communication. From the earlier approach of development being the administrative responsibility of the Government, we have witnessed the increasing role of the Voluntary Organizations, the Civil Society and even the private players. The Constitution's 73rd Amendment has mandated the process of decentralization of powers and functions right down to the gram panchayat levels. From the earlier concept of centralized planning and administration of developmental schemes, we have come to grassroots planning and administration.

The changed operating environment of rural development has meant rapid changes in the basic concepts and approaches to Rural Development and Panchayati Raj also. Cognizant of the changed reality, the earlier programmes of rural development have been restructured, merged or modified to meet the current needs. Furthermore, this process of change has now become an ongoing reality and in order to be properly tuned to the requirements of clear conceptualization, good planning and successful implementation of Rural Development and Panchayati Raj programmes, the necessary skills and capabilities of the functionaries have to be continuously upgraded.

A new paradigm has started starting from the central level to state level in developing the projects as well as provisioning of services through partnership with private players. PPP project have now taken center stage while delivering the required services while maximizing the efficiency and maintaining the required standards. States are now moving slowly and gradually and adopting the private efficiency in delivering public goods and services. Thus, state governments are seriously looking for projects that can be built, operated and managed by private players. Apart from economic and commercial projects that attracted private players till now, it is now moving beyond and structuring the social infrastructure projects in such a way to attract the private players in a sustainable way.

Odisha is exploring and adopting PPP mechanism where private investment in public infrastructure development or services is encouraged with the objective of leveraging risk and harnessing expertise of private partners. Provisioning of piped drinking water and related services have been high on the development agenda of the government.

Thus, CIRC has been entrusted to develop a PPP model for "Integrated piped drinking water and waste water management model" for the state. 6 clusters have been selected and perception survey has been conducted to find out general public's reaction regarding the private players' intervention, their willingness to pay, affordability and existing service level parameters. A PPP model has been developed and discussed with the department of drinking water and sanitation. It has been decide to conduct a training programe for DTMU official dealing with water and sanitation who could act as master trainer to further disseminate the same in district and block level.

Objective of the training Programe:

- To develop skills and competencies of the people related to rural development.
- Increase the reach of training to district, block and village levels.
- Improve the quality of training at all levels for enhancing organizational effectiveness.
- Bring about better coordination and networking among institutions of training in diverse sectors.
- To sensitize them with new way of developing projects through PPP mode
- To make them understand the nitty gritty of PPP projects and how they can bring about the change, not only by participating but also being able to be a partner in the process
- To make the panchayat understand the value it brings to the table and empowering them to take their own decision
