We seek a leader with expertise in the areas of economic governance, infrastructure, capacity building etc, to lead a dedicated team of young professionals at CUTS Institute for Regulation & Competition (CIRC), New Delhi. The person will be responsible for conducting research, designing research projects, developing training materials, and capacity building initiatives, and supervision of the team effort in this regard. Knowledge of practical aspects of public policy or legal issues is desirable. The job will involve working with different centres of the parent organisation, CUTS International.

Responsibilities

- Carry out independent primary and secondary research that will feed into the capacity building initiatives and consolidate organization's expertise;
- Writing and publishing various research outputs, viewpoints/op-eds on regular basis;
- Designing various training programmes and courses, keeping with the organizational thrust, and preparing resource materials for the same;
- Identifying and liaising with resource persons/faculties for the capacity building initiatives;
- Liaison with funders and prepare project proposals, concept notes, etc;
- Overseeing and coordinating the team and their endeavours, to pursue the organization's goals and vision;
- Collaborate with external service providers/partners for projects and liaise with them for implementation of deliverables according to time lines;
- Building collaboration with various universities and other research institutions in India and abroad;
- Work closely with the Board for strategy, planning and time lines of research, training and fund raising activities.
